PART 6 INFORMATION FOR PROPOSERS-Roof

6.1 Contract Documents

The Request for proposal, Part 1, SECTION 00 4100, SECTION 07 6200, SECTION 07 5800, SECTION 07 5300, SECTION 01 2200, SECTION 01 2100, SECTION 01 1000, Part 5, Part 6, Appendix roof plans, Bwatc Protest procedures are the contract documents that will form The Contract. Proposers should examine each part of the Contract Documents.

6.2 Date and Place of Opening

Pursuant to the Request for Proposals the sealed proposals will be received by the Blue Water Area Transportation Commission, 2021 Lapeer Avenue, Port Huron, Michigan, 48060, until 2:00 pm EST on April 25, 2025. They will be privately opened and reviewed and evaluated per Part 1.0 of this contract.

6.3 Printed Pricing Proposal

All price proposals must be submitted upon the form provided – *FORM 00 4100 – Pricing*. Price Proposals submitted in any other form will be considered non-responsive and will be rejected. They must be signed and acknowledged by the proposer in accordance with the directions in the proposals. In order to ensure consideration, the proposal should be enclosed and marked "DO NOT OPEN UNTIL 2:00 PM LOCAL TIME, April 25, 2025".

Note: The solicitation provides for the proposed price to be based on payment terms of 30 days after acceptance of the completion of the project.

6.4 Omissions and Discrepancies

Should a proposer find discrepancies in or omission from the specifications or contract documents, or should they be in doubt as to their meaning, they should notify at once the Contract Administrator, who may send a written instruction to all bidders.

6.5 Term of Proposal Effect

All proposals shall remain in effect for a period of ninety (90) days from the date of opening.

6.6 Acceptance or Rejection of Proposals

The Commission reserves the right to reject any and all proposals for sound, documentable, business reasons without limiting the generality of the foregoing. Any proposal which is incomplete, obscure, or irregular may be rejected and one or more items in the price schedule

may be rejected. Any proposal in which prices are omitted or in which prices are obviously unbalanced, may be rejected. Any proposal accompanied by any insufficient or irregular bid deposit may be rejected. Conditional proposals or those which take exception to the specifications may be considered non-responsive and may be rejected.

6.7 Air Pollution

The Contractor and suppliers must submit evidence to the Commission the governing air pollution criteria will be met. This evidence and related documents will be retained by the Commission for examination by the Federal Transit Administration (FTA).

6.8 Acceptance and Payment Terms

BWATC will notify the Contractor, in writing, within thirty (30) days after completion of the project if it has or has not been accepted. A letter on non-acceptance will furnish details of the deficiencies. An invoice will be furnished with or immediately prior to the completion of the project.

6.9 Time for Executing Contract and Damages for Failure to Execute

Any Contractor whose proposal is awarded will be required to execute the Contract within seven (7) days after notice that the Contact has been awarded to them. Failure to do so shall constitute a breach of the Agreement affected by the acceptance of the proposal.

The damages to BWATC for such a breach will include a loss of interfacing with its program and other items whose accurate amount will be difficult or impossible to complete. The amount of the bid security, if applicable, accompanying the proposal of such proposer shall be retained by BWATC as liquidated damages for such breach. In the event any Contractor whose proposal shall be awarded shall at its option determine that such proposer has abandoned the Contract and thereupon his proposal and the acceptance thereon shall be null and void and BWATC shall be entitled to liquidated damages as provided above.

All items subject to this procurement shall be ordered with in a sixty (60) day after the proposal due date. Delivery, installation, and integration will be made on all items no later than ninety (90) days after the issuance of purchase orders.
